## **Purpose of Lite Paper**

We are the Damex Group, a digital asset broker, custodian, and payments business that has been operating since 2017. This lite paper outlines the context of our digital asset finance application 'damex.io' launched in 2023 and the sale of our native utility token, 'Damex Token'.

The Damex Token is being issued and sold by Damex LTD, a company registered in Gibraltar and a subsidiary of the Damex Group that is registered with the Gibraltar Financial Services Commission for the purposes of the token sale.

The Damex Group reserves the right to update any of the utility features of the Damex Token and Damex.io Application or the timings of product rollouts at its sole discretion and subject to various regulatory approvals. As a result, this light paper may be updated from time to time and displayed on damex.io.

Full information on related entities in our group to this token sale can be found in the legal information at the end of this document.

## What is the Damex App?

The Damex App is a smart finance application that enables users to use and exchange digital assets and fiat currencies within an application, as well as spend using Damex-branded Visa debit cards.

The Damex App will also use non-fungible tokens and our native Damex Token to reward individuals for being healthy and active.

Damex is gamifying the digital asset finance application experience. The damex.io application and Damex Token will incentivise you to:

- 1. Be a healthier individual
- 2. Earn financial rewards
- 3. Give back to the world

## Why damex.io?

The inspiration for the damex.io application and Damex Token arose during the 'Covid-19 lockdowns of 2021/22'. Millions of people around the globe have suffered both physically and mentally due to Covid-19 restrictions.

We wanted to give back to our communities by:

- 1. Supporting individuals to live healthier lives
- 2. Educating individuals and businesses about digital assets
- 3. Promoting sustainability and helping the environment by incentivising people to walk more

### About damex.io

Established in 2017, Digital Asset Management Limited, also previously known as DAM or DAM Ltd, was one of the first companies in Gibraltar to receive the prestigious Distributed Ledger Technology authorisation from the Gibraltar Financial Services Commission ("GFSC"). DAM is approved to offer crypto custodianship and broker/dealer services as a financial institution. The Damex Group has around 65 staff based globally, with our headquarters in Gibraltar. DAM has since expanded to the Damex Group of companies, complementing the digital asset ecosystem with its various offerings and ventures, including its venture capital arm.

The Damex Application is offered by damex.io UAB to users in the UK and the EEA, with over [actual number of users] registered users. damex.io UAB and DAM Ltd are respectively registered agents/distributors of Modulr Finance in the EEA, UK and Gibraltar. This has enabled Damex to issue IBANs (bank account numbers), sort codes, and Damex Visa debit cards to its customers since 2023. DAM Ltd is currently awaiting authorisation from the GFSC to offer digital asset services in the Damex Application. #### Selected Protocol

The primary Damex Token will be minted on the Ethereum blockchain and then bridged to other networks, including Solana and Binance Smart Chain (BSC).

## Damex Buy Back & Burn Programme

Up to 20% of revenues from the Damex application will be used to buy Damex Tokens from the market. Tokens will either be burned (destroyed) or used as rewards for users in the damex. io ecosystem. The decision is at the full discretion of the Damex group and is subject to further details on buyback & burn. This is also subject to the distribution of the application across the Damex group.

#### **Voting And Governance**

As part of the future utility of the Damex Token, the Damex group will enable Damex Token holders to vote on particular features through voting in-app or on-chain. Holders will be able to vote for features in the application, token listings, and more through surveys or other voting/governance. 
